Please be advised that we process your personal data when collecting a vehicle.

### Who is responsible for the processing of data?

The data controller within the meaning of the data protection legislation is

### Which of your data do we process? And for what purposes?

We process the data you have provided when picking up a vehicle for identification and documentation purposes only.

### What legislation is this based on?

The processing of your personal data in connection with a request for information is based on Article 6 (1) lit. b) and c). It specifies that the processing of data is permitted if the processing of data is related to the performance of a contract or a legal obligation.

### How long will the data be stored?

Your personal data will be deleted or blocked once the purpose for storing the data no longer exists. Data may be stored beyond that point if this has been provided for by European or national legislation, by EU regulations, EU laws or other provisions the data controller is subject to.

### Who will receive my data?

**In general, your personal data are not being disclosed to third parties. Your data will be forwarded to the client if he requests a proof that the vehicle has been collected.**

### Where is your data processed?

The data is processed exclusively in the branch that collects the data.

### Your rights as a "data subject".

You have a right to be informed about the personal data we process about you.

In the event of a non-written request for information, we may request evidence showing that you are the person you claim to be.

If legally entitled to, you may also request that your personal data is corrected, deleted, or their processing is restricted.

You may also object to the processing of your personal data if legally provided for. The same applies to the right to data portability.
